(2010-11) 93	Minutes 93.1 The minutes of the meeting held on December 14 th were agreed and signed. 93.2 The actions from the meeting of 14 th December had been discharged.	
(2010-11) 94	County and District Councillors Reports 94.1 County Councillor West gave an update on the progress of the County Council deliberations on budgets. He advised that at that time things were not far enough forward to ascertain what if any direct effect it would have on the Parish and the Council's finances. Once more is known he will present it to a later meeting. 94.2 District Councillor Clough outlined progress with the District Councils budget deliberations and said that many possible areas of savings were being considered but that no decisions had been made so far.
